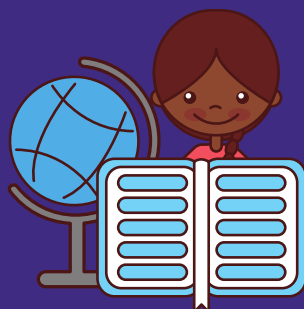

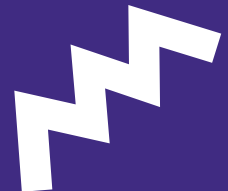

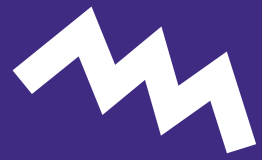

Article, Section Article VIII: Officers-Page 8 Section 1

CURRENT VERSION

The officers of the Mississippi PTA shall be a president; three (3) vice presidents: vice president for leadership, vice president for education, and vice president for legislation; a secretary; and a treasurer.

PROPOSED VERSION

The officers of the Mississippi PTA shall be a president; three (3) vice presidents: vice president for leadership, vice president for (education) **communications**, and vice president for legislation; a secretary; and a treasurer.

RATIONALE

This designation aligns with the duties of the office.

CURRENT VERSION

A. Each officer shall be a member of all local PTA chartered by the Mississippi PTA.

PROPOSED VERSION

A. Each officer shall be a member of an **active** local PTA chartered by the Mississippi PTA

RATIONALE

To allow for more board member

CURRENT VERSION

B. No officer may be eligible to serve two consecutive terms in the same office.

PROPOSED VERSION

B. **An** officer may be eligible to serve two consecutive terms in the same office.

RATIONALE

To allow for more board member

CURRENT VERSION

Each officer elected at an annual convention shall take office following the close of such annual convention or July 1st and shall serve for a term of two (2) years or until their successor is elected. The vice presidents shall take office at the close of the annual convention; the president, treasurer and secretary on July 1st.

PROPOSED VERSION

Each officer elected at an annual convention shall take office on July 1st and shall serve for a term of two (2) years or until their successor is elected. **During an election year, the newly elected President shall represent MS PTA at the NPTA Summer Convention. If for any reason the new President is unable to attend, the next representative will be chosen in this order of listing; VP of Leadership, VP of Legislation and VP of Communications.**

RATIONALE

The change will allow the officers to close out the school year and allow the newly elected President to received NPTA training.

A (1) vice president for leadership, (2) vice president for legislation (3) vice president for communication.

RATIONALE

The designation aligns with the job description.

C. perform such other duties as may be assigned by the president for the promotion of Mississippi PTA activities; **such as coordinating all training activities and providing educational resources for Mississippi PTA.**”

RATIONALE

Further defines the duties.

Section 4. The Vice President of Education shall: direct all educational activities related to the Mississippi PTA Bulletin;

Section 4. The Vice President of **Communications** shall: direct all communication activities related to the Mississippi PTA; **to include but not limited to newsletters, e-Newsletters, website, social media, etc.**

RATIONALE

Further defines the duties of the position. .

G. submit the books annually for an audit by an independent auditor selected by the **Board of Directors and the books submitted by July 15th.**

RATIONALE

Reduce conflict of interest

CURRENT VERSION

Section 9. At all meetings of the board, seven (7) members of the board shall constitute a quorum for the transaction of business.

PROPOSED VERSION

Section 9. At all meetings of the board, **five (5)** members of the board shall constitute a quorum for the transaction of business.

RATIONALE

Allows for the conduct of business in the instances when board membership is too low to meet quorum requirement

CURRENT VERSION

PROPOSED VERSION

Section 11. Regular and special meetings of the board may be held by telephone or electronic conference system that allow all participating members to concurrently hear and speak to each other during the meeting. RATIONALE

Allows compliance with Mississippi State law and allows for the conduct of business.

B. Committee on Elections Section 1 - Item A

CURRENT VERSION

Section 1. A committee on elections consisting of five (5), non-first year members of the State Board of Directors, shall be chosen by the executive committee at least sixty (60) days prior to the convention. The chairman shall be a member of the executive committee. Probationary, first-year board members shall not be members of this committee. The members shall be notified of their appointment to this committee by the president at least thirty (30) days prior to the convention.

PROPOSED VERSION

Section 1. A committee on elections consisting of five (5) members of the State Board of Directors, shall be chosen by the executive committee at least sixty (60) days prior to the convention. The chairman shall be a member of the executive committee. The members shall be notified of their appointment to this committee by the president at least thirty (30) days prior to the convention.

RATIONALE

The changes will allow the board to fill Committee positions when Board membership is too low to comply.

CURRENT VERSION

B. This committee shall be composed of at least one (1) member from the northern, central, and southern regions and not more than two (2) members from a single region for a total of five (5) members. Committee members shall not be duplicative of the members of the committee on elections. Probationary, first-year board members shall not be members of this committee.

PROPOSED VERSION

B. This committee shall be composed of at least five (5) members of the State Board of Directors. Whenever possible each region should be represented by one (1) member. Committee members shall not be duplicative of the members of the committee on elections whenever possible.

RATIONALE

To allow members to serve on duplicative committees if board membership is too low.

Section 2 - Item B

CURRENT VERSION

B. Send a list of the nominees to the state office, from which a copy shall be sent by the State Office staff to each member of the State Board of Directors at least sixty (60) days prior to the opening of the convention. A list of these nominees shall be mailed to local units thirty (30) days prior to the convention.

PROPOSED VERSION

B. A list of the nominees shall be sent electronically and or mailed to each member of the State Board of Directors and local units at least thirty (30) days prior to the opening of the convention.

RATIONALE

MS PTA no longer has an office or office employee. Thirty (30) Days' notice will allow everyone to receive notification simultaneously. It will also allow the list to be sent electronically.

CURRENT VERSION

C. Report to the convention on the first day of the session, at which time additional nominations may be made from the floor

PROPOSED VERSION

C Candidates who intend to run from the floor must provide notice to the president and the chair of the nominating committee of such intentions fifteen (15) days prior to the date of the first session.

RATIONALE

Allows the Committee sufficient time to verify the qualifications of candidates running from the floor that included membership of a local unit in Good Standing and prior membership on the State Board of Directors.

CURRENT VERSION

A. Only a member of a local PTA/PTSA unit shall be eligible to hold office in the Mississippi PTA or any of its divisions.

A. Only a member of an active local PTA/PTSA unit shall be eligible to hold office in the Mississippi PTA or any of its divisions

RATIONALE

Allow for more individual to qualify for elected office on the State Board of Directors

CURRENT VERSION

B. Only those who have served on the State Board of Directors shall be eligible for nomination or election to office.

PROPOSED VERSION

B. Only those who have served on the State Board of Directors or a current member of an active PTA/PTSA unit shall be eligible for nomination or election to office.

Allows compliance with Mississippi State law for committees to conduct business in person and electronically.

Article XV: Convention Page 18

Section 4; Cancellation of
Convention; Item A

CURRENT VERSION

A. In the event of an emergency, epidemic or other disaster, the State Board of Directors shall have the authority to determine by two-thirds (2/3) vote whether or not a convention shall be held. The vote on this question may be taken by mail in the event a meeting of the State Board of Directors cannot be held.

PROPOSED VERSION

A. In the event of an emergency, pandemic or natural disaster the State Board of Directors shall have the authority to determine by majority vote whether or not a convention should be held. The vote on this question may be taken by mail or electronically in the event a meeting of the MS PTA Board of Directors cannot be held. All actions adopted at an electronic or virtual meeting shall be official actions of the voting body.

RATIONALE

To provide for electronic annual meeting and convention of Mississippi PTA to conduct affairs of MS PTA when an in-person convention is not possible.

CURRENT VERSION

B. In the event that a convention is not held, the State Board of Directors shall plan procedures for conducting all necessary business by mail which shall include the elections of officers.

In the event that an in-person convention is not held, the State Board of Directors can elect to hold its annual meeting and or convention virtually, if conditions allow, for conducting all necessary business electronically which shall include the election of officers. All actions adopted at an electronic or virtual meeting shall be official actions of the voting body.
